



Three Options and Legal documents required for Registration of a Company in the Fujairah Free Zone

Option 1: Branch Office

Document Required

- Investors can submit their requirements by filling in the Application Form. Initial approval will be granted on reviewing the form and relevant documents. Transit visas can be arranged for the investors to visit the site upon request.
- The licence will be issued within a maximum a of 48 hours upon final agreement on the terms and conditions of the contract and the fulfilling of the first year's financial commitments (premises rent, licensing fees, Fujairah Chamber of Commerce registration).
- Investors leasing Trading Offices or pre-built units can take over the premises with immediate effect upon the issuance of licence. However, investors signing contracts for constructing a customised building can also utilise Free Zone facilities to prepare their manufacturing units during the period of constructing their units.

Option 2 & 3: FZE/FZC

Document Required

- Investors can submit their requirements by filling in the Application Form. Initial approval will be granted on reviewing the form and relevant documents. Transit visas can be arranged for the investors to visit the site upon request.
- The licence will be issued within a maximum a of 48 hours upon final agreement on the terms and conditions of the contract and the fulfilling of the first year's financial commitments (premises rent, licensing fees, Fujairah Chamber of Commerce registration).
- Investors leasing Trading Offices or pre-built units can take over the premises with immediate effect upon the issuance of licence. - AED 2800 (for warehouse) - One Time charges for Free Zone Utilities
- AED 5000/- - Incorporation Charges(One time -Only applicable for FZC & FZE)
- AED 1500/- per person - Residence Visa (Deposit of AED 1000/- on each visa)
- AED 15,000/- Refundable Security Deposit

7. Open Land
